USGA RULES GOVERN ALL PLAY
EXCEPT WHERE MODIFIED BY LOCAL RULES

- **OUT-OF-BOUNDS:** Out-of-Bounds is defined by white stakes except for the road on number 10 where the course side edge of the curb defines the Out-of-Bounds. USGA Rule 18.2.
- **NO PLAY ZONES / ENVIRONMENTALLY SENSITIVE AREAS (ESA):** Entry into these areas is strictly prohibited; you must abandon your ball and proceed under USGA Rule 17.1d. ESA areas are defined by red painted lines accompanied by stakes (red with green caps). When painted lines are not present, the edge of the cart path or curb opposite of the course will define the margin of the ESA. The red painted lines and the edge of the cart path or curb supersede any ESA stakes that serve as indicators.
- **PENALTY AREAS:** Penalty Areas are defined by red or yellow painted lines and/or stakes. When painted lines are not present, the edge of the cart path or curb opposite of the course will define the margin of the penalty area. Painted lines and the edge of the cart path or curb supersede any stakes that serve as indicators. Penalty Areas are also defined by the edge of stone walls opposite of the course located on holes 4, 8, 9, 10, 13, 16 and 18. USGA Rule 17.
- **PENALTY AREA DROP ZONES:** Drop zones are located on holes 8 and 16 as an additional option to the Penalty Areas.
- **CART PATHS & STONE WALLS:** All concrete cart paths and stone walls are considered immovable obstructions. Players may take relief under USGA Rule 16.1a.
- **IMMOVABLE OBSTRUCTIONS CLOSE TO PUTTING GREEN:** Relief is available only when the ball and the immovable obstruction (i.e. sprinkler heads) lie in a closely-mown area and an immovable obstruction on or within two club-lengths of the putting green and within two club-lengths of the ball intervenes on the line of play. Players are entitled to drop ball within one club-length of complete relief.
